This will allow the County to reduce the 2024 tax levy by this amount. This will also allow us to decrease the tax rate to \$5.98 from \$6.01. Since the tentative budget has already been submitted to the Board of Supervisors for approval. The Board can make this amendment to the 2024 budget at the Board meeting.
