The regular meeting of the Ontario County Board of Supervisors was called to order at 6:30 p.m. via WebEx on ontariocountyny.webex.com and at 74 Ontario Street, Canandaigua, NY 14424, with Chairman John (Jack) Marren presiding.

The Pledge of Allegiance was led by Supervisor Tamara Hicks of the Town of Naples.

Upon roll call, all members of the Board were present.

Minutes of the preceding two sessions were approved without being read by motion of Supervisor Kristine Singer, seconded by Supervisor Ted Bateman; motion carried.

Deputy Director of Public Health Kate Ott gave a report on COVID-19 cases noting we have moved into the "Substantial" category.

County Administrator, Chris DeBolt reported there have been no new workforce cases since the last Committee reported. Mr. DeBolt and his team are working closely with all the school superintendents. There will be no state action, nor will there be K-12 guidance issued by the state. Mr. DeBolt reached out to the Finger Lakes Control room and was informed there would be no plans to reconvene the Control room; they will be doing it on their own. They have reached out to all the participating Counties and will be meeting for the first time on Monday, August 9th. They will be focusing on the schools to getting the kids back to school.

Chairman Marren granted privilege of the floor to Supervisor Dan Marshall.

Supervisor Marshall introduced Tracey Dello-Stritto, Executive Director of The Partnership for Ontario County and a member of the Substance Abuse Coalition and Mr. Andrew Rude, Coordinator of the Coalition and an Environmental Specialist for Council on Alcoholism and Addictions of the Finger Lakes.

Ms. Dell- Stritto and Mr. Rude gave a brief PowerPoint presentation to provide information for the municipalities to consider regarding The Marijuana Regulation and Taxation Act. Mr. Rude began by reiterating they are there to help municipalities make an educated decision regarding the Act with their choice to opt in or out. He reviewed important dates. He noted things to consider; zoning, increasing zoning regulations, education campaigns, and smoke-free zones. Ms. Dello-Stritto addressed the community aspect of the use of cannabis. She described the difference of inhaling verses ingesting

cannabis. She also described the difference of marijuana from the 1960s to now and the packaging and labeling of the edible cannabis. Ms. Dello-Stritto said that they as a coalition are there to help educate through presentations, forums, or campaigns.

WHEREAS, The COVID 19 pandemic has been a major public health undertaking since March of 2020 and effected the residents of Ontario County with over 7,400 positive cases being identified and still increasing; and

WHEREAS, The Federal Government accelerated the development of vaccines to help protect our nation’s residents; and

WHEREAS, The Governor and New York State Department of Health received vaccine and prioritized the administration of vaccine and recommended Emergency Medical Services (EMS) be present during the distribution to respond to any adverse reaction of the vaccine; and

WHEREAS, Ontario County Public Health received its first allocation of vaccine and began vaccination POD’s (Point Of Dispensing) in early January 2021 and requested the assistance of EMS providers to monitor and respond to any adverse reactions of vaccinated individuals; and

WHEREAS, The amount of time spent by EMS providers at vaccination POD’s has been a drain on their resources; and

WHEREAS, The American Rescue Plan allows for reimbursement of vaccination related expenses, including that of EMS providers; and

WHEREAS, The Health & Human Services and Ways & Means Committees recommend approval of this resolution; now, therefore, be it

RESOLVED, Invoices received from EMS providers: Canandaigua Emergency Squad, Inc, Finger Lakes Ambulance EMS, Inc and Victor Farmington Ambulance Corps are hereby approved for calendar year 2021 expenses for COVID 19 Vaccination related expenses in conjunction with the POD's conducted by Ontario County Public Health; and further

RESOLVED, These expenses will be paid and reimbursed by American Rescue Plan funds; and further

RESOLUTION NO. 375-2021

**RESOLUTION CALLING ON THE GOVERNOR TO COMPLETE
AFFORDABLE CARE ACT ENHANCED FEDERAL MEDICAID ASSISTANCE
PERCENTAGE RECONCILIATIONS THAT ARE YEARS OVERDUE AND
IMMEDIATELY RELEASE THE FEDERAL FUNDS
OWED TO COUNTIES AND NEW YORK CITY**

WHEREAS, The funding to support the Medicaid program is provided by a combination of federal, state and local resources; and

WHEREAS, The state requires the counties and New York City to contribute \$7.6 billion annually to pay for the federal and state defined and controlled program; and

WHEREAS, The locally required share of Medicaid funding paid in New York is the highest of any state in the country; and

WHEREAS, This large local funding share for Medicaid and other state programs is a major contributor to New York's high local tax burden compared to other states; and

WHEREAS, Under the Affordable Care Act the federal government provided an enhanced Medicaid matching share (eFMAP), which has saved New York state billions of dollars; and

WHEREAS, The state is required under federal law to share these savings with counties and New York City based on the proportionate share localities pay of the nonfederal match; and

WHEREAS, The state has utilized a methodology that provides 80 percent of these estimated federal savings to counties in the year the costs accrue; and

WHEREAS, The balance of savings owed to counties is supposed to be reconciled annually to ensure the withheld savings are transferred to county budgets and local taxpayers, as well as meeting the intent of federal law; and

WHEREAS, The last completed reconciliation was for state fiscal year 2015-16; and

WHEREAS, This leaves reconciliations four years behind the normal schedule, with more than \$800 million in federal funds being withheld from counties and New York City, by NYSAC estimates; and

WHEREAS, By not providing these federal funds it requires counties and New York City to reserve funds locally to make up for the loss, meaning local taxes have been kept higher than they need to be over multiple years, or local services had to be scaled back or eliminated; and

WHEREAS, In the years leading up to the last completed Efmapp reconciliation, counties were provided an estimate of their coming year Medicaid costs by September, in time to incorporate the savings in their budgets, which ceased when regular reconciliations ended; and

WHEREAS, The Health & Human Services, Governmental Operations and Insurance and Ways and Means Committees have reviewed the significant impact on our budget and desires New York State promptly cure these reconciliations and strongly recommends the adoption of this resolution; now, therefore, be it

RESOLVED, The Ontario County Board of Supervisors urges the Governor to complete the reconciliations from state fiscal years 2016-2017, 2017-2018, 2018-2019 and 2019-2020 as soon as possible and to provide counties and New York City a full accounting of the federal funds owed, and to take immediate steps to release the funds to localities; and further

RESOLVED, The state should also renew its practice of providing adequate notice to counties of coming year Medicaid costs so we can appropriately budget those savings for local taxpayers and to preserve highly desired quality of life services provided locally; and further

RESOLVED, That copies of this resolution be sent by the Clerk of this Board to Governor Andrew Cuomo, Senate Majority Leader Andrea Stewart-Cousins, Assembly Speaker Carl Heastie, Senator Pamela Helming, Senator Samra Brouk, Assemblyman Jeffrey Gallahan and the New York State Association of Counties.

**RESOLUTION NO. 376-2021
ONTARIO COUNTY LANDFILL FINANCIAL PLAN
FOR PERMIT SUCCESS PAYMENTS FOR 2022 - 2028**

WHEREAS, Pursuant to the terms and conditions of the Operation, Management and Lease Agreement (OMLA) from November 2003, Casella Waste Services of Ontario, LLC operates the Ontario County Landfill (the "Landfill"), located in Ontario County, New York, which property and facility is owned by the County; and

WHEREAS, Resolution No. 465-2003 mandates how payments received through the OMLA are to be used; and

WHEREAS, In 2014 Ontario County adopted its Solid Waste Management Plan (SWMP) that established an ambitious goal to increase waste reduction and diversion to 60% by 2024 and funding will be needed to establish and maintain the programs and capital investments necessary to achieve this goal; and

WHEREAS, Pursuant to Section 8.3 of the OMLA, last amended November 12, 2015, for the next 14 years Casella shall make an annual "Permit Success Payment" to the County of one million three hundred seven thousand five hundred fifty nine dollars and twenty five cents (\$1,307,559.25), for a total payment of eighteen million three hundred five thousand eight hundred twenty eight dollars (\$18,305,828.00); and

WHEREAS, Resolution No. 587-2016 amended Resolution No. 465-2003 to provide funds necessary to implement the adopted 2014 Ontario County Solid Waste Management Plan and establish a solid foundation for the management of the landfill; and

WHEREAS, The Planning and Environmental Quality and Ways & Means Committees recommend adoption of this additional amendment resolution to ensure Permit Success Payments for 2022 through 2028 are budgeted and utilized in a manner that is consistent with County funding priorities including implementation of the SWMP; now, therefore, be it

RESOLVED, Resolution No. 465-2003 is hereby further amended so that the revenues from the Permit Success Payments shall be applied as follows:

- a) Continuing from 2022 through 2028, \$753,000.00 annually shall be budgeted to fund implementation of the adopted 2014 Ontario County Solid Waste Management Plan or other such project, as determined by this Board, that

further the goal of increased waste reduction, recycling, reuse, and/or diversion of solid waste from being placed in a landfill; and

- b) In 2022, \$45,000 shall be transferred to the Workers' Compensation Fund to assist in providing adequate funding for this self-insured program; and
