Kate Ott provided a handout on Lyme disease to provide information on what it looks like when they do a quality improvement with staff. She reported 294 cases of Lyme disease in 2024. She said despite their best efforts, it continues to go up. She said anaplasmosis is another illness that can be shared by the black-legged deer tick. In the last 6 weeks, they have had 7 cases. Last year they had only 1 or 2 cases.

Kate Ott gave the following updates:

- ~ Their Emergency preparedness contract ends today and awaits federal confirmation for extension; the state readiness is confirmed.
- ~ They are working with the County Attorney's office on the new contract system. They have a little lag in the contracts with the BAAs; ironing out the logistics.
- ~ They did not get awarded the grants for maternal child health nor for rabies.
- ~ They are continuing with their community health assessment.

4. Mental Health Services:
