- Other costs that are hidden, such as storage, is there other equipment to maintain it?
- Estimated life of a new one.
- Something more than it is old, it doesn't work all the time, we need to replace it.
- More information on why it has to be done now.

Supervisor Grammar agreed on wanting to see a fuller picture, but is in support of the CIP.

7. District Attorney:

First Assistant District Attorney James Nobles gave a brief update on the Nordquist case, informing the committee that they have been able to secure two guilty pleas of the seven co-defendants. There are four in negotiations currently. They anticipate three or four more pleas by Labor Day, if not earlier. He said they originally thought they were looking at potentially five or six trials, but it may be down to three.

Sheriff Cirencione gave the following updates:

- ~ Jail population at 83; 63 males, 20 females, 4 boarded out, 1 state ready
- ~ Therapy graduation at 1:00 pm, July 9th.
- ~ The Jail security project is ahead of schedule.
- ~ Jail staffing; 6, potentially 7 correction officers starting July 13th, and a nurse starting on August 10th.
- ~ Overtime is down since the two officers came from their court schedule and were on the Monday to Friday day schedule.
- ~ They hope to pursue a Monday to Friday wheel with six to eight officers.
- ~ They regularly get written complaints about e-bikes and scooters. They recognized the problem and had a meeting with the County Administration, the District Attorney, and the County Attorney. There is a requirement to wear helmets, ride with and in traffic and not on sidewalks and are supposed to be 16 years or older to be on these. The majority of the problems they see are seen with 13, 14, and 15-year-olds. There is very little in the law for any enforceability. They are deploying bike patrol and road patrol officers to hit the trails, parks and areas of concern. The Town of Farmington is looking to pass a local town law. The results of a poll across the state have no policies.
- ~ They have been busy with the CMAC season, and it has gone well, but have been getting reports of partying and some underage activities, specifically in the Walmart parking lot.
- ~ The event with the July 4th fireworks at Outhouse park went well according to feedback.
- ~ They have had a couple of tragedies on the highways. A person in one of the accidents single-handedly assisted and saved four of the five people. Dr. Butler has been in contact with the officers who have had to witness the scene. There will be a recognition of the person who helped in saving the lives.
- ~ There is a definite correlation between detours and accidents.
- ~ Shared good news of two babies born to two different officers, a promotion to an officer, and two recruits on the road.
